

Square - Competition Terms

General

By participating in the Visa x Square FIFA World Cup 2026™ Promotion competition (**Promotion**), each participant acknowledges that they have read, understood and agree to be bound by these terms and conditions (**Terms**).

The promoter is Square AU Pty Ltd, ABN 38 167 106 176 of Queen & Collins, Lv. 8, 376-390 Collins Street, Melbourne VIC 3000 (**Promoter**). The Promotion commences at 9am (AEST) on 26/03/2026 and closes at 5pm (AEST) on 24/04/2026 (**Promotion Period**).

How to Enter

To enter this Promotion you must:

- Sign up to Square; and
- Take your first payment within 14 days of signing up, each within the Promotion Period.

This is a game of chance. The Promoter's decision is final and no correspondence will be entered into with participants. The Promoter may determine at any time whether or not to disqualify or invalidate any entry, or determine a participant's eligibility, in accordance with these Terms, in its absolute discretion.

Eligibility

Entry is open to eligible Australian residents only who are over 18 years of age and are able to claim the prize, including travelling on the dates specified by the Promoter and meeting all required travel documentation and United States entry requirements. Multiple entries are not permitted, and participants can only enter in their own name. Participants who have signed up to Square at any time prior to the Promotion Period are not eligible to participate in this promotion. Employees of:

- the Promoter, immediate family members of any employee, and any associated company or agency of the Promotion; and/or
 - any federal, territory, or local government agency and their immediate family members,
- are not eligible to participate in this Promotion.
